Minimum fee for the incorporation of a standard Jersey company, to include the establishment of the statutory and accounting records and for collecting the required due diligence **£2,500**

Additional fees for correspondence and meetings, non-standard capital structure or articles of association; specific advice concerning the intended activities of the company and arranging banking and investment facilities **Cost**

Charge for same day incorporation **£200**

Disbursements: telephone, electronic mail, facsimile, photocopying, postage, minute book and registers, share certificates and company seal, etc as required **Cost**

Minimum fee for the engrossment of a standard Jersey trust, to include the establishment of the trustee and accounting records and for collecting the required due diligence **£2,750**

Additional fees for correspondence and meetings, non-standard trust instruments, presenting specific advice and other additional work to settle assets on trust including arranging banking and investment facilities **Cost**

Disbursements: telephone, electronic mail, facsimile, photocopying, postage and minute book – approximately **£150**

External costs

Legal fees – minimum **£195**

Provision of corporate trustee services – annually in advance

- with underlying company **£2,500**
- no underlying company **£3,000**

Administration, accounting and bookkeeping determined by prevailing hourly rate **Cost**

Preparation of financial statements determined by prevailing hourly rate **Cost**

Compliance fee - annual to cover all regulatory reporting **£500**

Disbursements: telephone, electronic mail, facsimile, photocopying, postage etc **4%**
